SUBJECT: Solicitation for Programs and Services for Youth under the Workforce Investment Act, WIA Title I-B Funding Stream, in Local Workforce Area #5 (LWA 5) – Kane, DeKalb and Kendall Counties

SECTION I -- BACKGROUND:

Proposals are being solicited from qualified sources to provide year-round services to eligible youth as defined by the Workforce Investment Act of 1998 (WIA). Funds made available through this Request For Proposal (RFP) are intended for the benefit of WIA Title I-B eligible youth of the Local Workforce Investment Area #5 (LWIA #5) which includes Kane, DeKalb, and Kendall Counties. (Not more than 10% of any provider's enrollments can reside outside the three-County boundaries.)

The services offered to youth under this legislation are overseen by the Youth Council of the River Valley Workforce Investment Board (YC-RVWIB) in conjunction with the Kane County Board Chief Local Elected Official, and administration of the grant by the Kane County Department of Employment and Education (KCDEE), Administrative and Fiscal Agent for WIA Title I-B funds for LWIA #5.

Council Mission:

To develop and maintain a system to prepare youth for current and future career opportunities.

For additional background information, the bidder is requested to review the following resources:

- ✓ The LWIA #5 River Valley Workforce Investment Board/Youth Council 5 Year Plan and Strategic Youth Goals available on the following website: www.rivervalleywib.org.
- ✓ Section 664.405 and Section 664.410 of the WIA regulations, describing service and design elements that must be provided through the local workforce area's youth services and programs.

Qualified bidders are requested to submit proposals that articulate their ability to deliver comprehensive educational, developmental, and employment preparation services to WIA eligible low-income youth age sixteen through twenty-one (16-21), serving either in-school high school seniors or out-of-school youth, with activities that prepare the WIA eligible youth for employment through job readiness activities, work experience, hands-on and classroom training, and/or through the provision of Individual Training Accounts (ITAs) in short-term occupational skill training. Pre-assessment and post assessment of job readiness and basic academic skills, as well as career exploration activities are to be conducted with the youth. It is expected that these activities funded through the grant will result in the positive outcomes prescribed in the WIA performance measures. Emphasis will be on programs that will provide youth the proper tools to attain the education and skills needed to find and keep a job and advance in the workforce.

Priority of services is given to covered persons under the "Jobs for Veterans Act" that are eligible for WIA. Programs need also link students to services satisfying local labor market needs and necessary support services which aid the youth in their development as citizens and workers in our communities.

A. DESCRIPTION OF ELIGIBLE POPULATION

The eligible youth population under this grant opportunity must be between the ages of sixteen and twenty-one (16-21); meet low-income guidelines as defined in the Workforce Investment Act (total family income at or below 70% of the Federal Lower Living Standard Income Levels); and reside in Kane, DeKalb, or Kendall Counties. In addition to meeting the age and low-income status, youth served must also have a barrier to employment, which may include one or more of the following:

- Deficient in basic literacy skills,
- A school dropout,
- Homeless,
- Runaway,
- A foster child,
- Pregnant,
- A parent,
- An offender, or
- An individual who requires additional assistance to complete an educational program, or to secure and hold employment.

Documentation must be obtained and provided to prove the above factors.

B. REQUIRED PROGRAM OUTCOMES:

Qualified program providers are requested to submit proposals that deliver specific activities for the eligible population of youth which will result in the expected outcomes listed below:

U. S. Department of Labor Common Measures for Youth

1. Placement in Employment or Education (first quarter after exit)
2. Attainment of a Degree or Certificate (diploma, GED, or certificate by end of 3rd quarter after exit)
3. Literacy and Numeracy Gains (defined by DOL in Educational Functioning Levels)

For all out-of-school youth, - Students that are basic skills deficient must increase one educational functioning level in reading and/or math within 12-months of first registration. This is for the U. S. Department of Labor Literacy/Numeracy measure.

Following attainment of the above objectives and exit criteria, bidder must provide students with follow-up services for a period of 12 months.

C. WIA PROGRAM ELEMENTS

Eligible youth will need to have access to the following ten (10) WIA required program elements (*20 CFR 664.410* Final Regulations). No single provider needs to provide all ten (10) elements, however, these must be options available to youth based on their individual needs, determined through their objective assessment and written into their individual service strategy (ISS). The Bidder's proposal must address specific partnerships developed to link youth to these various services and resources and how the bidder intends to follow students' progress in the linked activities. A matrix is provided on Page 21 to be completed by the Bidder addressing the elements below.

Improving Educational Achievement

1. Tutoring, study skills training, and instruction leading to secondary school completion, including dropout prevention strategies;
2. Alternative secondary school offerings;

Preparing For and Succeeding in Employment

3. Summer employment opportunities directly linked to academic and occupational learning;
4. Paid and unpaid work experiences, including internships and job shadowing, as provided in 20 CFR 664.460 and 664.470;
5. Occupational skill training;

Supporting Youth

6. Supportive services, which may include the services listed in 20 CFR 664.440;
7. Adult mentoring for a duration of at least twelve (12) months, that may occur both during and after program participation;
8. Follow-up services, as provided in 20 CFR 664.450; and
9. Comprehensive guidance and counseling, including drug and alcohol abuse counseling, as well as referrals to counseling, as appropriate to the needs of the individual.

Developing the Youth as Citizens and Leaders

10. Leadership development opportunities, which include community service and peer-centered activities encouraging responsibility and other positive social behaviors.

In completing the matrix on Page 21 for the above elements, describe partnership relationships that will be relevant to the delivery of the specific program element. Explain how participants will link to these partners' service element and how the Bidder will monitor the student's progress within these linkages. Describe each partner's role and responsibilities. Explain how partners' services will be funded and/or paid for.

D. PROGRAM ACTIVITIES:

Qualified bidders must address each of the following components (i.e. Outreach, Recruitment, etc.) in a Narrative submission. See Section II-Part A. Proposal Narrative Instructions.

Outreach, Recruitment, Eligibility Determination, Assessment and Testing, and Development of Individual Service Strategy –

Outreach, Recruitment, Eligibility: The bidder must have a comprehensive plan and approach to identifying and recruiting eligible youth. KCDEE program staff involvement in outreach, recruitment, eligibility determination, assessment, and development of the student's individual service strategy may vary by selected providers. The bidder's proposal should be clear as to the level of involvement they are proposing they will have in the delivery of these components. The level of involvement will be negotiated based on the selected provider's demonstrated experience. KCDEE provides periodic training and refresher meetings with providers on eligibility determination. KCDEE will have final approval of student eligibility.

Testing and Assessment, and Development of Individual Service Strategy: (Academic and Career Interest) – Students will need to be pre and post tested utilizing TABE testing. Based on pre-test results, students may be determined deficient in basic skills (definition found in WIA eligibility guide). The bidder will need to describe how it will address student's academic needs, whether they include remedial instruction, tutoring assistance, or other means of assisting the youth to improve where needed. KCDEE provides access to the Skills Tutor internet-based instructional software if the provider does not have an alternative offering for students. KCDEE can arrange training on this software for providers. In addition, career Interest testing is important to the overall service strategy, and will be required in developing students' service strategy for work-related activities and/or occupational training. See sections below.

Work Preparation/Work Readiness – For students needing connection to employment, the bidder's program will need to prepare students accordingly. An orientation to the wage and hour laws as well as hazardous occupations information should be provided. In addition, some form of career exposure and interest exploration should be provided.

Work-Based Learning – These activities include paid or unpaid work experience, internships, job shadowing, or possibly On-the-Job Training for older youth. For programs that include work-related activities, a tool for identifying student's career interests will need to be implemented. Student's assessment results will be reported using an Individual Service Strategy format provided by KCDEE.

Occupational/Classroom Training – If the bidder's program includes occupational/classroom training, a tool for identifying student's career interests will need to be implemented in order to reinforce the training selected. Students will be required to apply for financial assistance before utilizing WIA funds for occupational training. The bidder may need to assist the youth in this process. Students should be encouraged to pursue training in the growing fields identified by the River Valley Workforce Investment Board which are: Healthcare, Manufacturing, Transportation/Warehousing/Logistics, Information Technology, Finance, Hospitality, Tourism, and Retail.

Individual Service Strategy / Program Referral – Youth must be provided information regarding the full array of applicable or appropriate services available through qualified providers through the One-Stop or affiliate sites; and will be referred to appropriate training and educational programs that have the capacity to serve them either on a sequential or concurrent basis. The youth must be provided services that address their needs identified through the objective assessment or discovered through the delivery of services to the youth. Note: youth may access some services available through the One-Stop or affiliate sites preceding their referral to a bidder's program.

If the bidder's program does not directly provide programming to meet all of the referred youths' needs, the bidder must then identify how they plan to connect the youth to community services, through which providers, and how the bidder will coordinate and monitor these services with the youth. **For example:** A youth may be appropriate to be referred to a Selected Provider's program that focuses on work preparation and job placement, however, the youth is deficient in their basic skills. The Selected Provider will need to develop a plan with the youth to set goals to improve the deficiency and link that youth to a source through which that service can be provided. Youth must be referred to and/or have access to year-round programming, be provided linkages between academic and occupational learning, and be connected to the job market and area employers. The Selected Provider will be responsible for continued communication with the participant, continually assessing where the student is in their progress toward their goals, re-developing and reassessing their situation and re-developing plans and goals with the youth as appropriate and necessary.

Subsequent adjustments made to the youth's individual service strategy will be required to be submitted to the assigned KCDEE representative from the selected provider not less than every thirty (30) days.

Tracking the Youth through Services – This will be the responsibility of the Selected Providers. The ISS identifies achievements, objectives, appropriate employment goals and appropriate services for the individual. It is a living, breathing document that must be reflective of the student's progress through the sub-awarded program services. The selected provider must update the ISS not less than every thirty (30) days during the entire program's time span. These updates serve as progress reports that must include goal attainment, post-tests, services provided, case management notes, and customer satisfaction feedback from the youth. The selected provider will agree to accepting technical assistance if deemed necessary to ensure positive outcomes for the youth.

Case Management and Counseling – This will be the responsibility of the Selected Providers. Case Management is a required program element under the Workforce Investment Act. Each youth enrolled in the program must be provided with a case manager/counselor who is expected to have frequent and regular contact with the youth during the entire program's time span. At a minimum, monthly contact must be made, documented, and recorded as to the student's progress, plans, needs, etc. Given the high-risk nature of this population, much more frequent contact is likely to be necessary to ensure the youth remains engaged in the program and the program is meeting their individual needs and objectives. Continued communication and continued assessment with the youth is essential to their success. This continued interaction is often referred to as following up with the participant. This type of follow-up is not to be misconstrued with WIA required follow-up services described below. The bidder should review the WIA legislation and Federal regulations as a resource. The Bidder should describe how they will keep students active and engaged. As a part of the case management activities, the student should be made aware of

their role and responsibilities in participating in the Selected Provider's program, including a structured exit activity that leads to the development of the required 12-month follow-up activities referred to below.

Student Stipends and Incentives – This will be the responsibility of the Selected Providers

Stipends and incentives are allowable expenses given appropriate utilization and available budget. If the bidder intends to provide these, a specific plan is needed that identifies how students will earn and be awarded incentives and/or stipends, amount of each incentive and/or award, and identify what documentation will be provided to support attainment of the incentive award. Incentives and/or stipends should support specific objectives leading to positive attainment of WIA performance outcomes.

Support Services – This will be the responsibility of the Selected Providers

Selected providers should conduct an assessment of the students' supportive service needs and address how these needs will be met directly by the selected provider and/or through other linkages. A copy of the bidder's specific policies will be required.

Job Search and Placement Assistance - This will be the responsibility of the Selected Providers

Selected providers should conduct structured job preparation activities, preferably in a group setting, to assist youth in preparing and searching for employment. A description of these activities and expected placement outcomes is to be provided.

Exit Strategy and Follow-Up Procedures – This will be the responsibility of the Selected Providers

The selected provider will need to work with KCDEE performance management staff to determine the best and most appropriate time to exit students from WIA services and begin provision of follow-up services. KCDEE provides periodic training and refresher meetings on performance measures for WIA participants. All youth must receive some form of follow-up services for a minimum duration of 12 months **following the date of exit from the program**. These activities may include, but are not limited to: leadership development activities, contact with the youth's employer and assistance with addressing work-related problems that may arise, assistance in securing better jobs, career development and further education; work-related peer support groups, adult mentoring, and tracking the progress of the youth in employment after training. The provision of these follow-up services should be discussed with the participant as they exit the program and the scope and intensity of these services must be developed into a written follow-up plan for services centered on the specific needs of the youth.

E. **MINIMUM SUBAWARD GOALS:**

Bidders will need to clearly describe how their proposed program will contribute to the local workforce area's attainment of the minimum WIA performance measures.

Complete Section I-E in addition to addressing this in the Narrative.

The Youth Council and KCDEE as the administrative entity are responsible for ensuring there is a mixture of available programs that will net expected performance in all performance measures applicable to WIA youth. Bidders must identify and describe their specific program design in detail, outlining how the programming will result in the expected performance outcomes.

The Bidder's progress toward attaining program goals and WIA performance measures will be evaluated on a monthly basis. It is the expectation set by the Youth Council that not less than 75% of prior year students have completed the bidder's program activities and are included in the performance pools for the three (3) WIA performance measures. Unsatisfactory progress may trigger action up to and including deobligation and/or termination of the sub-award. Consideration for funding extensions or renewals will be contingent upon a number of factors, including but not limited to the availability of funds, the program's demonstrated successful performance in meeting the minimum program goals and objectives described above within the time span of the program year and/or sub-award period, and other factors deemed appropriate by the Youth Council RFP Committee and KCDEE as administrative entity.

A table is provided in Section I-E for bidders to supply the planned number of students to achieve these goals.

F. PROGRAM DESIGN

The bidder's program for eligible youth under the Workforce Investment Act should be age and developmentally appropriate based on each individual's assessed needs and goals. Programs to be considered will offer students the link to long-term interventions for youth through ongoing partnerships with local one-stops, area agencies, high schools, community colleges, townships and employers. Programs for the youth will emphasize identifying an appropriate career path, assisting youth improve basic skills deficiencies (as needed), preparing and providing youth with skills for success in the workplace (work readiness skills), placement assistance into employment, dropout prevention strategies for older in-school youth, program retention services for students in GED, and/or occupational certificate training through the issuance of an ITA (Individual Training Account). Programs with demonstrated outcomes that mirror the WIA performance measures will be given greater attention.

Bidders will need to describe their ability to deliver programs leading to the above stated expected outcomes. The Youth Council seeks new and innovative program delivery methods that will engage youth. Other program concepts, strategies, and approaches will be given consideration, however, the proposal must articulate strategies for keeping the youth engaged, how they will identify potential quitters, and the strategies to be used to motivate and re-engage them for successful completion.

F. PROPOSAL REVIEW AND SELECTION CRITERIA:

The first step in the review of proposals will consist of a preliminary check to ensure all required documents have been submitted. If not, the proposal will be rejected from consideration.

The second step will be a review of the bidder's qualifications, financial and management systems, and past performance. If the bidder's qualifications are not satisfactory or past performance has not been acceptable, the bidder's proposal may be rejected from consideration.

The complete proposals will be reviewed, scored, and rated by representatives of the River Valley WIB Youth Council (Youth RFP Committee) and an Administrative review team of KCDEE. Questions or items requiring clarification in any proposal will be documented by the reviewers and compiled into one summary for the bidder to address. The review team will jointly interview each Bidder and meet to discuss the proposals. The Evaluation rating sheets will be finalized and subawards will be negotiated with those bidders that are recommended for approval. A copy of the evaluation rating tool is attached. In-kind contributions are not a requirement of this award solicitation, and they are not an element in the evaluation rating. Subaward negotiations will be with representatives of KCDEE.

COMPETITIVE SELECTION PROCEDURE – REQUEST FOR PROPOSAL
TERMS AND CONDITIONS

1. **Proposal Acceptance.** Proposals will be received at the North Aurora office of the Kane County Department of Employment & Education until the date and time specified – see specifics noted in RFP document. Late proposals shall be rejected and returned to the sender. Incomplete proposals will be rejected from consideration.
2. **Proposal Preparation.** Proposals must be submitted on this form and all information and certification called for must be furnished. Proposals submitted in any other manner, or which fail to furnish all information or certification required, may be summarily rejected. Proposals shall be filled out legibly in ink or typewritten with all erasures, strikeovers and corrections initialed in ink by the person signing the proposal. The proposal shall include the legal name of the bidder, the complete mailing address, and be signed in ink by a person or persons legally authorized to bind the bidder to a contract. Name of person signing should be typed or printed below the signature.
3. **Errors in Proposals.** Bidders are cautioned to verify their proposals before submission. Negligence on the part of the bidder in preparing the proposal confers no right for withdrawal or modification of the proposal after it has been received.
4. **Reserved Rights.** The Kane County Department of Employment & Education and the Youth Council of the River Valley Workforce Investment Board reserves the right at any time and for any reason to cancel this Request for Proposals, accept or reject any or all proposals or any portion thereof, or accept an alternate proposal. The Kane County Department of Employment & Education reserves the right to waive any immaterial defect in any proposal. The Kane County Department of Employment & Education and the Youth Council of the River Valley Workforce Investment Board may seek clarification from any bidder at any time and failure to respond promptly is cause for rejection.
5. **Incurred Costs.** The Kane County Department of Employment & Education and the Youth Council of the River Valley Workforce Investment Board will not be liable for any costs incurred by bidders in replying to this Request for Proposals.
6. **Right to Make No Awards.** The Kane County Department of Employment & Education and the Youth Council of the River Valley Workforce Investment Board are under no legal requirement to execute a contract on the basis of any proposal. Proposals will be evaluated by appropriate committee of the Youth Council of the River Valley Workforce Investment Board with representatives of the Kane County Department of Employment & Education. This Review Team shall have the authority and discretion to determine the qualifications, responsibility and capabilities of the bidders and other factors. The Committee's final recommendation and reports shall be forwarded to the River Valley Workforce Investment Board for consideration and approval of sub-awards.
7. **Contingency of Awards.** Awards resulting from review and evaluation of proposals will be contingent upon successful negotiation of a sub-award.
8. **Interpretation or Correction of Bidding Documents.** Bidders shall promptly notify the Kane County Department of Employment & Education of any ambiguity, inconsistency or error that they may discover upon examination of the bidding documents. Interpretations, corrections and changes will be made by addendum. Each bidder shall ascertain prior to submitting a proposal that all addenda have been received and acknowledged in the proposal.
9. **Negotiations.** The Kane County Department of Employment & Education and the River Valley Workforce Investment Board reserves the right to negotiate specifications, terms and conditions that may be necessary or appropriate to the accomplishment of the purpose of this RFP. The entire proposal shall be made an integral part of the resulting sub-award. This implies that all responses, supplemental information, and other submissions provided by the bidder during discussions or negotiations will be held by the Kane County Department of Employment & Education as contractually binding on the successful bidder.
10. **Notice of Unacceptable Proposal.** When the Review Team determines a bidder's proposal to be unacceptable, such bidder shall not be afforded an additional opportunity to supplement its proposal. The decision of the Review Team shall be final.
11. **Law Governing.** This RFP and any sub-awards shall be governed and construed according to the laws of the State of Illinois.
12. **Resolution of Compliance Issues.** A sub-award with the selected bidder may be withheld, at the sole discretion of the River Valley Workforce Investment Board, if the bidder currently has outstanding issues of questioned/disallowed costs or non-compliance with relevant statutes, regulations, or sub-awards, until such issues are satisfactorily resolved. The River Valley Workforce Investment Board may withdraw sub-awards if resolution of these issues is not satisfactory to the Board.
13. **Conflict of Interest/Code of Conduct.** Any members, officers, employees or agents of the River Valley Workforce Investment Board or any of its committees, including the Council, involved in the procurement process is prohibited from accepting gifts, favor or anything of monetary value from existing or potential sub-recipients or parties to sub-agreements. Any situation that suggests that a decision was influenced by prejudice, bias, special interest, or personal gain, shall be avoided. If an individual has a conflict of interest, they must declare a conflict on the official record, and abstain from voting on, and/or participating in, the procurement.
14. **Program / Sub-award Duration.** The YC-RVWIB is soliciting only for programs that provide year-round programming for youth. The sub-award will be written with Selected Providers for an initial twelve month period. Renewal of the Sub-award may be available for up to two (2) additional one-year periods, contingent upon the Sub-recipient's performance, available funding, demonstrated need to extend services, and/or other criteria deemed appropriate by the Grantee or River Valley Workforce Investment Board. Automatic extensions should not be assumed by any provider receiving an

award as a result of this solicitation. The Bidder must plan its program delivery in a way to ensure required performance outcomes can be achieved within the contracted time span of the program.

15. **Fund Availability.** While funding from the Department of Commerce & Economic Opportunity has not been made available to the LWIA yet for Program Year 2010, an estimated amount of approximately \$1,000,000 is planned to be available for delivery of year-round youth programs across the three-County area of Local Workforce Area #5 – Kane, DeKalb, and Kendall Counties from July 1, 2010 through June 30, 2011.

The Youth Council of LWIA #5 is committed to ensuring there will be proportionate distribution of funds to the three Counties within the Local Workforce Investment Area because they are responsible for providing services throughout both the urban and rural areas of Kane, DeKalb and Kendall Counties.

The Youth Council of the River Valley Workforce Investment Board and the Kane County Department of Employment & Education reserve the right to accept, deny, or negotiate proposals above or below amounts requested, in order to provide adequate programming within the geographic regions of the local workforce area, as well as meet the funding priorities set forth in the law (i.e. priority for out-of-school youth).
